**Report Highlights:**

Rates for the variable levy on imported sugar are established by this resolution, and range from \$220 to \$270 per metric ton, based on average monthly prices at the New York Board of Trade. These rates go into effect December 1, 2007, and remain in effect until May 31, 2008, unless either Russia accedes to the World Trade Organization in the meantime or the NYBOT average monthly price goes over \$259.99 per metric ton.

**Executive Summary**

Rates for the variable levy on imported sugar are established by this resolution, and range from \$220 to \$270 per metric ton, based on average monthly prices at the New York Board of Trade. These rates go into effect December 1, 2007, and remain in effect until May 31, 2008, unless either Russia accedes to the World Trade Organization in the meantime or the NYBOT prices goes over \$259.99 per metric ton.

**Text of Resolution No. 671**

Begin text:

Resolution of October 12, 2007, No. 671 "On seasonal tariffs for raw cane sugar and various types of sugar imported into the Russian Federation in 2007 and 2008"

In accordance with Article 6 of the Law of the Russian Federation "On Customs Tariffs" the government of the Russian Federation resolves:

1. To confirm the attached rates of seasonal duties on raw cane sugar and sugar with aromatic flavoring or color additives imported into the Russian Federation from December 1 to December 31, 2007, and from January 1 to May 31, 2008.

The Federal Customs Service to ensure collection of seasonal duties in accordance with Russian Federation law.

2. To establish that the validity of rates of seasonal duties set by this resolution ends before the established term expires in the event of the Russian Federation's accession to the World Trade Organization (as of the date of entry into effect of the international agreement on the Russian Federation's accession to the World Trade Organization) or in the event that the average monthly price for raw sugar on the New York Board of Trade, calculated in accordance with the resolution of the Government of the Russian Federation of December 15, 2004, No. 786 "On tariff regulation of sugar imports into the Russian Federation," exceeds 259.99 U.S. dollars per ton.

3. This resolution goes into effect one month from the date of its official publication.
