Report Highlights:

On April 30, 2001, Mexico's Secretariat of Economy (SE) announced that on June 1, 2001, it will conduct an auction of permits to import 46,120 MT of U.S. dry edible beans (HS 0713.33.99). The stated quantity represents the second and final two-thirds of the total NAFTA tariff-rate quota (TRQ) for CY 2001. The auction for the first one-third was held on March 19, 2001 (See MX1023).

On April 30, 2001, the Mexican government published in the Diario Oficial (Federal Register) the Secretariat of Economy's (SE) announcement that on June 1 it will conduct the auction of the remaining NAFTA TRQ import permits for 46,120.5 MT of U.S. dry edible beans (except for planting), in lots of no more than 1,500 MT. Participation in the auction is limited to traders and packers in operation for at least one year. The auction itself will be conducted at SE in Mexico City at 10:30 a.m. on June 1. SE auctioned the first tranche of this year's TRQ (15,373.5 MT) on March 19, 2001. It should be noted that this first tranche was announced by SE a month before it took place (see MX1023). Under NAFTA, Mexico's minimum access obligation for U.S. dry edible bean in 2001 is a tariff rate quota of 61,494 MT.
