USTR allocated the increased quantity as follows: 40,000 MTRV to Canada, 68,278 MTRV to Mexico, and 163,877 MTRV to the global refined sugar TRQ. See USTR press release 8 Aug. 2008. The quantity that entered prior to 1 Oct. 2008 was 102,022 MTRV. This TRQ filled on 10 Oct. 2008.

The FY 2008 global TRQ totals 7,090 + 163,877 + 68,278 = 239,245 MTRV.

Tranche 2 – 13 Nov. 2008 – 10,000 MTRV

Tranche 3 – 28 Nov. 2008 – 10,000 MTRV

Tranche 4 – 11 Dec. 2008 – 10,000 MTRV

Tranche 5 – 29 Dec. 2008 – 10,000 MTRV

5/ The FY 2008 TRQ for Canada consisted of the original 10,300 MTRV plus the additional 40,000 MTRV, with entry extended until 31 Dec. 2008. The quantity that entered prior to 1 Oct. 2008 was 19,309 MTRV. Added to the Oct-Dec 2008 entries of 15,594 MTRV, total entries were 34,903 MTRV .

6/ This quantity entered in the period 1 Oct. - 10 Oct. 2008.
