

World Agricultural Production

Brazil Expects Record Soybean Harvest

Brazil's 2009/10 soybean production is forecast at a record 65.0 million tons, up 2.0 million from last month and up 8.0 million or 14 percent from last year. Bumper crops are expected in the states of Mato Grosso and Parana, the first and second-largest producing states, respectively. Area is forecast at a record 23.1 million hectares, up 0.4 million from last month and up 1.4 million or 6 percent from last year's harvested area. Record soybean area was planted this year due to higher soybean prices and greater profit margins in comparison to corn. Yield is forecast at 2.81 tons per hectare, slightly above the 15-year trend yield of 2.80 tons per hectare.

Rains arrived early in most parts of the country, which encouraged farmers to plant earlier than usual. Rains were also above average throughout the major soybean regions, and most regions have finished planting. Planting was delayed, however, in the state of Rio Grande do Sul due to heavy rains during November and early December, and 10 percent of the crop remained to be planted as of early January. Excess soil moisture in Rio Grande do Sul reportedly reduced germination in some fields and also increased pest infestations, diseases, and weeds.

Harvesting started before Christmas this year in Mato Grosso which is earlier than normal due to early planting and more short-season varieties planted. This year short-season varieties increased to approximately 35 percent of the crop in Mato Grosso, whereas last year's crop had only 10 percent. Short-season varieties with improved yield potential are becoming more popular because they are less susceptible to rust and can be followed with second-season (safrinha) corn or cotton crops. *(For more information, contact Curt Reynolds at 202-690-0134, reynoldsc@fas.usda.gov).*

Australia Cotton Forecast Slightly Decreased

Australia's 2009/10 cotton production is forecast at 1.75 million 480-pound bales, down 3 percent from last month, but up 0.25 million or 17 percent from last year. Harvested area is forecast at 195,000 hectares, up 31,000 hectares or 19 percent from last year. The yield is forecast at 1954 kg/ha, down 2 percent from last year. Early-season rains and increased water availability in the Murray River and Snowy System diversions resulted in improved water entitlement allocations. Cotton sowing operations in October saw favorable end-of-spring soil moisture conditions. In November and early December, however, the majority of the cotton growing regions experienced drier-than-normal conditions coupled with above average temperatures, high evaporation, and high crop water use. Producers in New South Wales and Queensland were desperate for rainfall in order to limit early irrigation and ease pressure on already-stretched irrigation supplies. Some farmers started reassessing their irrigation budgets and dryland crop management. The crop is approaching the flowering stage, critical for yield development. The current planted-area and production forecasts represent a significant recovery from record-low levels experienced in the 2007/08 season. The current forecasts, however, are still low in historical terms because water availability remains a critical problem along with limited irrigation capacity. *(For more information, contact Dath Mita at 202-720-7339, mita.dath@fas.usda.gov).*

Corn Production Looks Promising in Argentina

The USDA forecasts Argentine corn production for 2009/10 at 15.0 million tons, up 1.0 million from last month. Area is estimated at 2.0 million hectares, down 11 percent from last year's harvested area of 2.25 million hectares and down 27 percent from the 5-year average. The forecast yield of 7.5 tons per hectare is up 34 percent from last year's drought-impacted crop. The crop stage now varies from the eight-leaf stage to near maturity for the bulk of the crop, with the exception of newly-planted fields. Corn condition is better than expected due to recent favorable weather.

Most of the crop in the core production area is in good condition. Some corn areas have had more than ample rain recently, but flooding has been limited. An area within the district of

Roque Saenz Pena in southern Cordoba has been inundated with rain. One report suggested that 500,000 hectares had been affected by heavy rain, but it is unknown how much of that area was planted to corn. Parts of northern Buenos Aires and southern Santa Fe province also had heavy showers. Most of the last of the corn was planted the past few weeks. Moderate weather, along with a forecast of drying conditions this week will benefit crop development in most areas. Production estimates vary due to the wide range of planting dates across the country. Over three-fourths of the crop is approaching the pollination stage, so weather during the next few weeks will be key to determining the final crop output. *(For more information, contact Dr. Denise McWilliams at 202-720-0107, Denise.McWilliams@fas.usda.gov).*

Using world wheat production as an example, changes between the January projection and the final estimate have averaged 3.2 million tons (0.6 percent) and ranged from -8.3 to 6.4 million tons.
