 - THE SYSTEM WILL ASK FOR THE CLASS TYPE OF THE VISA: TEMPORARY (TEMPORAL)
 - THE SYSTEM WILL ASK FOR THE CATEGORY (CATEGORIA): **TP-1**
 - THE SYSTEM WILL ASK TO UPLOAD SUPPORTING DOCUMENTS:
 1. COPY OF THE PASSPORT
 2. SUPPORTING LETTER REQUESTING US THE ISSUANCE OF THE VISA INFORMING THE LENGTH OF STAY
 3. EBOLA VIRUS DISEASE SURVEY
 4. A PASSPORT STYLE FACE PHOTOGRAPH/WHITE BACKGROUND/ 3 CM. W X 4 CM. H/ J.PEG FORMAT
 5. COPY OF A PREVIOUS VISA IF YOU HAD ONE
 - ONCE YOU'VE COMPLETED THE VISA APPLICATION, THE SYSTEM WILL GIVE YOU A REGISTERED NUMBER. PLEASE INFORM THE CONSULATE BY EMAIL OF THIS NUMBER, THE NAME, PASSPORT NUMBER AND DATE OF BIRTH OF THE APPLICANT, TO BE ABLE TO AUTHORIZE THE VISA.
 - PLEASE DISREGARD THE NOTE WHERE IT SAYS "TO CONTINUE THE PROCESS YOU MAY PAY THE STUDY OF THE VISA" AS THE TP-1 VISA HAS NO COST.
 - ONCE THE APPLICATION IS APPROVED, AN EMAIL NOTIFICATION WITH THE E-VISA INCLUDED WILL BE SENT TO THE EMAIL REGISTERED ON THE APPLICATION, ALLOWING THE PERSON TO TRAVEL WITH THE E-VISA.
 - THE PROCESSING TIME FOR VISAS TO BE APPROVED IS 3 BUSINESS DAYS FROM RECEIVING THE EMAIL.
 - THE ELECTRONIC VISA ALLOWS THE PERSON TO ENTER AND EXIT THE COUNTRY IF THE LENGTH OF STAY IS LESS THEN 30 DAYS.
- IF THE LENGTH OF STAY IS LONGER THAN 30 DAYS A STICKER VISA WILL BE STAMPED IN THE PASSPORT.
- PLEASE NOTE THAT THE CORRECT FORMAT FOR THE DATE OF BIRTH IN COLOMBIA IS DD/MM/YYYY AND THAT YOUR NAME HAS TO BE EXACTLY AS IT APPEARS ON YOUR PASSPORT.
 - WHEN THE COUNTRY OF BIRTH IS UNITED STATES, YOU CAN ENTER "ESTADOS UNIDOS"
