(4) I certify and affirm that \_\_\_\_\_ maintains invoices along with other supporting documentation (such as price lists and other technical descriptions of the fabric qualities) showing the dollar value of such fabric purchased, the date of purchase, and evidencing the fabric as woven cotton fabric of 80s or higher count and 2-ply in warp. For purposes of this affidavit, the date of purchase is the invoice date, and the dollar value is determined excluding duty, shipping, and related costs.

(5) I certify and affirm that the fabric referenced herein was suitable for use in the manufacturing of men’s and boy’s cotton shirts.

I certify and affirm that to the best of my knowledge and belief all information contained in this claim and affidavit is complete and correct and no false claims, statements, or representations have been made.
